- Our Research & Referral services help connect families with early care and education programs in a number of ways.
- Our Alternative Payment Program (Vouchers) provides very low-income families with subsidies to pay for child care.
- We have two programs that assist family child care providers that range from helping individuals obtain their child care license to supporting high quality care with veteran providers.
- Our training and professional development services are open to families and child care providers alike. They include training in areas such as child development, special needs, CPR and First Aid.
- Our inclusion services include enhanced child care referrals for families whose children have exceptional needs. We also assist families in obtaining developmental screenings for special needs.

Prospective board members understand the value of quality child care and early education. They embrace the diversity of the children, families, and providers we serve, and are willing to share their skills to further the mission of 4Cs.
